5 Chairman's Report

The Chairman, Roger, echoed Margaret's thoughts and indicated that he had nothing to report not covered by the Agenda but felt that the League was in good shape with a strong management team running it and wished everyone the best for the 2025 season.

He mentioned that it would be nice if someone would come forward as Competitions Organiser.

6 Hon. Secretary's Report

First of all I'd like to thank my fellow officers together with all clubs and teams for their cooperation and support throughout the 2024 season

We are fortunate that Salop Leisure continued to sponsor us and hopefully they will continue their sponsorship for the coming season once I have contacted them later this week.

7 Treasurer's Report

The Treasurer, Margaret Cooper, confirmed that the Statement of Account had been prepared and just needed signing by Paul Adams (Battlefield). A copy is included on page 5 of these minutes.

Margaret emphasised that the sponsorship money of £350 from Salop Leisure was an enormous help in keeping our subs at a very low level but that we must not ever take it for granted.

However, again there was a deficit for the year of £695.96, and because of this, Margaret proposed that subs for 2025 would need to be increased by £10 to £35 per team and following a show of hands, this was unanimously passed by those present.

She told the meeting that our bankers, Lloyds Bank, had recently introduced a monthly fee of £40 per month and following much discussion it was unanimously agreed that she should contact other banks with a view to moving the account where it would be cheaper.

Margaret pointed out that the Honoraria to be paid to some League Officials needed to be approved at each AGM and so she proposed that they remain the same as the previous year at £50 for the Secretary, £50 for the Treasurer, £100 for the Fixtures/Results Secretary and £50 for the Competitions Organiser and this was unanimously carried.

Finally, Margaret reminded everyone that subs could be paid after the end of the meeting or no later than immediately prior to the Pre-Season Meeting at Meole Brace BC on 10th March either by cheque or cash. Anyone wishing to pay by online transfer could do so and she gave out the bank details.

Oswestry Church proposed and Prince of Wales seconded that we adopt the Statement of Account as presented and this was passed unanimously.

8 Results Secretary's Report

We started the season with 58 teams with one team (Hanwood B) pulling out soon after the start of the season.

The season went extremely well with no major disruptions due to weather and just a handful of postponed matches.

9 Competition Secretary's Report

The **Singles** competition was held at Meole Brace with a healthy turnout of 32. The main comp winner was Mark Thomas (Castlefields) who beat Dave Povey (Pontesbury) and the consolation winner was Nick Marshall (Prince Hotel) who beat Ernie Shea (Battlefield).

The **Doubles** competition, also at Meole Brace, was well attended with a record 33 pairs taking part. The main comp winners were Barry Keep and John Nash (Castlefields) who beat Mike Greaves and Brian Richards (Crescent) and the consolation winners were Chris Davies and Vernon Biggs (Meole Brace) who beat Graham Warren and Patrick Bennett (Oswestry Church).

Presidents Day, again at Meole, was as usual a great success although disappointingly we only attracted 28 participants, same as the previous season, with the winner being Dave Povey (Pontesbury). Dave was presented with the Bill Garratt Presidents Cup and an engraved tankard.

Team K/O comps finals: The Dick Meyrick was held on OSBC number 2 and won by Castlefields who beat Telepost. The Ron Smout was held on Meole No 1 green and won by Albert Road B who beat Dorrington. The Sponsors Shield was held on OSBC No 1 green and won by Battlefield D who beat Meole D.

The **Dixon Cup** annual inter-league match v Mid Shropshire Seniors was this year played in our area on OSBC No 1 green where we won by just 2 chalks and 7-5 on games.

I would like to thank Meole Brace BC and OSBC for allowing us to use their greens and facilities this season.

13 Notices of Motion:

A Proposed by the Secretary and seconded by the Chairman: Add wording (in bold) to the second paragraph of Rule 11(c): Players may only participate in one of these competitions which means that once a player has played for one team, they cannot play for any other team even if their original team gets knocked out of the competition unless a dispensation is applied for and granted by the Executive Committee. For the semi-final and the final all players must have been registered with this League for at least 28 days and where a club has two or more teams, a player is not eligible to play unless that player has played in at least two League matches for that team unless a dispensation is applied for and granted by the Executive Committee. Motion CARRIED

- **B** Proposed by the Fixtures Secretary and seconded by the Chairman: *If a player will reach* the age of 65 on or before the last match of the current season, they will be eligible to play from the start of the season. Motion CARRIED
- C Proposed by the Secretary and seconded by the Treasurer: Rule 13, replace first sentence of first paragraph with: *The top three teams, individual* men's winner and individual lady winner in each division will receive prize monies. Motion CARRIED
